SECOND QUARTER 2014 HEALTHCARE REVIEW

Dear Clients and Friends,

Scott-Macon is pleased to present our quarterly Healthcare Review covering the second quarter of 2014. If you haven't done so already, please email me at ncortright@scott-macon.com to automatically continue receiving our publications in the future as we are transitioning to digital publishing with email distribution.

Pages four and five represent a visual snapshot of the average multiples for all of the healthcare, medical and pharmaceutical transactions that either closed or were announced during the second quarter, along with the average multiples for the major publicly-traded healthcare, medical and pharmaceutical companies.

The Mergers & Acquisitions analysis begins on page 6. Deal volume was exceptionally strong in the second quarter in terms of the number of announced and closed transactions, however very few deals involved publicly-disclosed valuation information. In the Services segment, the larger deals by disclosed values included Fresenius's announced \$600 million deal for hospitalist player Sound Inpatient Physicians; Wex' \$532 million acquisition of payments firm Evolution1; Magellan's \$370 million acquisition of CDMI in the medical and pharmacy benefit space; American Financial's acquisition of Summit in the workers' compensation arena; and Xerox/ACS's acquisition of workers' compensation services company ISG for \$225 million.

Provider transactions begin on page 11, again like services with a high volume of transactions but few deals with disclosed valuation metrics. Larger deals included AmSurg's \$2.4 billion takeover of clinical solutions company Sheridan Healthcare; Ventas's \$2.3 billion offer for real estate giant American Realty Capital Healthcare Trust; and Kindred's hostile spurned \$1.7 billion offer for Gentiva. In addition, Ventas announced its \$899 million offer for 29

senior housing facilities, surgical services player Symbion received a \$792 million offer from Surgery Partners, and behavioral specialist Acadia announced its \$660 million deal for Partnerships in Care.

The Products arena starting on page 16 witnessed the quarter's blockbuster deals, as usual, in terms of dollar volume. On top was Valeant's \$59.6 billion offer for Allergan, followed by AbbVie/Shire at \$52.6 billion, and also Covidien's proposed acquisition by Medtronix at \$46.9 billion. In addition, Zimmer announced a \$13.9 billion offer for surgical products company LVB; Mallinckrodt announced its \$4.8 billion offer for Questcor, and Carlyle Group closed on its \$4.2 billion takeover of Ortho-Clinical Diagnostics.

Following the mergers and acquisitions analysis, we present an analysis of publicly-traded Services, Providers, and Products companies by sector. Mean EBITDA multiples for Services companies ended the quarter at 11.3x (compared to 11.6x in Q1 2014); Providers at 11.5x (up from 10.7x in Q1 2014); and Products at 12.7x (up from 12.4x in Q1 2014). Technology services companies ended the quarter at an average EBITDA multiple of 15.7x (up from 14.1x in Q1 in 2014), while Outsourcing services companies traded at 11.8x EBITDA as of June 30th (down from 12.8x in Q1 2014). The Insurance segment EBITDA multiple came in at 8.7x (up from 8.4x in Q1 2014).


